<u>Great Lakes Shipwreck Marine Sanctuary:</u> Daryl Ertel and Bruce Lynn_from the Great Lakes Shipwreck museum made a presentation to the board explaining the economic impact and benefits of supporting their application to NOAA for a national marine sanctuary along the Lake Superior shoreline.
