We will not be able to open the facility for use until the governmental restrictions are lifted. **New Business**:

<u>Township employees</u>: Employees have been on call only coming in for essential tasks since the shelter at home order was given by the governor. The township has reviewed the requirements mandated for work sites that are to remain open and feel that we can schedule and accommodate our employees safely.
