Re: January and February 2022 patrols

I would like to commend Burt Township and their Board for entering into a road patrol agreement with the Alger County Sheriff's Office. The 6 months we have worked patrols in Burt Township have been a pleasure to myself and my staff. Our deputies are working hard to provide the best service possible to the residents of Burt Township. Since we have entered into this contract, our office has done many positive things for the safety and well being of the residents. Undersheriff Blank started a "Burt Township" Rescue 21 team. We have donated a side by side emergency vehicle for their use, and the 10 member team have trained on the machine, and have it ready for an emergency response. Our office has also assigned 2 Deputies to work these patrols for Burt Township. With the help of Sheri Schafer, we were able to convince the Alger County Board to allow me to send another deputy to police academy to help fill the patrol schedule in Burt Township. The County of Alger has agreed to pay for the training for this deputy. I would also like to thank Sheri and the Board for finding a place to store a patrol vehicle, and an area for our deputy to work out of. We recently have concluded an interview with Grand Marais resident Nick Paul. Nick Paul has agreed to come to work for us, and I am very confident Nick will be a great asset to our department and Burt Township in the event of an emergency, and some patrol hours. As I stated in November, we are working towards a "community policing" concept in Burt Township, and our deputies are ready to approach their duties in Burt Township with that concept.

I have included with this letter, an invoice for \$2,313.37 for our patrols in January and February of this year. I am also including a report generated by Captain Waldron on the activity worked during these 2 months in Burt Township. I applicate for the late reporting, but we are working on a system with Burt Township that will expedite our billings and activity reports.
