How do you feel about the proportion of short-term rentals to long-term rentals and homeowner occupied residences within the community?

#### Question #35

## Sensitive Natural Areas

- Rivers, Federal Lands that are being timbered (overly clear cut), and subject to fires from debris
- Lakeshore, green space corridors along H58 (east and west) and M77
- Federal lands that are being timbered (overly clear cut) and subject to fires from debris;
- School forest, lonesome point, eastern dune lakeshore
- Re-route atv trails away from homes (x4);
- The entire village and surroundings (x4);
- Coast Guard Point, PRNL, Kingston Plains, atmosphere, noise pollution,
- Trails in the woods (x9),
- Traffic on H58,
- Private property from 4-wheelers and snowmobiles;
- Sable lake;
- The Bay; Food truck should not be at the bay;
- Wildlife areas;
- Downtown (x2);
- Parks trails and fishing spots;
- Lakefront area from Agate beach to First Creek. Actually, the entire area around Agate Beach needs to be kept green space as long as there is adequate parking. The breakwall needs to be kept up and the parking area graded.;

- Coast Guard Point should not be developed to the point of detracting from the beauty. No large buildings.;
- Area around town park. Township should have purchased the available beach front and added to the park.;
- All public access points to beaches;
- All rules should be the same for everyone!!! Yes the pier area and agate beach should be protected and limited for emergency situations. Example July 4th is so overcrowded should an emergency happen there is not proper security for the amount of people attending. Busiest times have no apparent emergency plans. Side by sides and ATVs rule the road instead of the road edge.;
- Abundance in nature for GM is centered on peaceful experiences outdoors and quiet is part of it. Protecting the NOISE LEVEL is equally important to other protections.;
- I would hope older structures can be preserved to keep the feel of Grand Marais. Maintaining public access to waterways including the lakeshore is important, too.;
- Protect your landscape from intrusive wind and solar farms;
- Dunes and beach particularly at and around the deck at N Lake Ave and below the campground. Beach and Sucker River Access at Cemetery Road.
- Woodland Park: It has far too many campsites (raise the fee; reduce the number of sites); Protect the School Forest from overuse by ATVs;
- The town's quaint, historical atmosphere coupled with the natural beauty of the harbor. Under no circumstances should windmills be visible. The paving of H58 will ruin the essential character of Grand Marais unless there are extensive (and expensive) efforts-initiated ASAP to mitigate the impact of huge increases in traffic and the types of vehicles that will be coming through town.;
- School Forest must be off limits to motorized vehicles. Off-road vehicles are travelling along the North Country trail to the beach and destroying both the paths, the environment, and the ability of hikers to enjoy the natural beauty and feel safe. ORV and ATVs need to be prohibited from School Forest and from off roading anywhere that is not formally approved and maintained. Also, Agate Beach is full of trash, including cigarette butts, food containers, and dog waste. The additional parking area was installed with no environmental review--it is probably illegal and has resulted in significant sand erosion, drifting, and damage to adjacent properties;
- Lake Superior, roadways. There has been a marked increase in trash on the Lakeshore and along H58. Putting a dumpster at the Adam's Trail staging area would be extremely helpful. Our neighborhood continually picks up trash that we in turn dispose of at a cost to us personally. If you want to encourage tourism and bringing people into the area, you must also address the impact. The harbor/freshwater sources need to be protected from breeches in private septic systems and therefore a community sewer system needs to be implemented;
- The community center/recreational center;

- Grand Marais Bay, the Sucker River, the Dunes and beaches, and our lakes. Surrounding state land that is overrun by off road motor vehicles;
- Understanding that the Grand Marais economy exists entirely dependent on tourism and such tourism is directly contingent upon the bounty of recreational public lands it is without question that any and all growth within Burt Township should be very limited and planned, and all surrounding pristine lands should be protected extensively.;
- The ground water, harbor and rivers;
- Greenspace, bay hill, national park, beaches, forestry outside national park;

- Does it make sense financially?
- They are inefficient; a money pit! They are contrary to providing a natural scenic landscape and an eyesore!:
- They are supposed to be noisy! Keep away from residential areas;
- Located so no residences are immediately affected;
- They are not attractive and noisy and a menace to wildlife.
- Never acceptable, however could be accommodated in outlying areas that are state owned forest land if adequately planned. Viewshed protection is a key component of long-term protection of Burt T's assets. This potential should be rigorously examined by the Master Plan to clearly establish where such development will not negatively impact view sheds and quality of life.
- You need open areas for wind turbines, outside of town would be best;
- Wind turbines destroy the habitat and environment around their installation. Light flicker and sub-sonic sound from wind turbines create mental health issues. Wind dependent systems are inefficient and unreliable. There are no options for end of use life cycle.

It takes so many resources and so much energy to build one that they could spin themselves into oblivion and NEVER generate enough energy to pay for their own construction. Do not do this to Grand Marais!;

- Woodland Park should have been kept to its original campground size instead of cramming twice the people in than it can handle. Grand Marais property owners should feel that Woodland Park belongs to them because it does. Charge more money for each site if need be. It used to be a park now it's just a campground.
- I have felt that in the last several years Grand Marais has really missed the mark on the direction it has taken. Instead of promoting quiet sports like cross country skiing and hiking they have encouraged ATVs, snowmobiles, motorcycles and other motorized recreation that does not honor the beautiful and pristine abundance of nature that many of us were drawn to in the first place. Time to wake up!
- While there is an economic benefit to a few in the business community, I believe even they would be better off in the long run by restrictions [to ORVs/snowmobiles]
- Healthy growth is not a bad thing. It is a change and people do not handle change well. If Grand Marais does not make some changes, the town is going to die! The area is beautiful so find a way to share it with the world. I pray for wisdom for the residents because they are going to tax us away from the area- then where will they be?
- Grand Marais' primary economy, and its resident population include tourism and retirement age residency. Presently, tourism is mostly limited to 3 to 5 months a year, mostly during summer and winter seasons; while presently we have less than 60 or so year around residents, mostly retirees. These things have been the case for a long time and are most likely to remain the case for the foreseeable future. We need to keep these two things firmly in mind when planning for Grand Marais' future. We also are a somewhat isolated community, which can be problematic. If the U.S. embraces electric vehicles, and/or if energy costs continue to remain high and increase further, I suspect that we will see more people moving to larger cities where housing and transportation are more convenient and affordable. That has been a world-wide trend for perhaps the past 150 years or so. If this trend continues, it will also mean less people living small, isolated communities like Grand Marais. Perhaps it will also mean only the wealthy can afford the costs of living in small, isolated communities, unless the basic needs of these residents are somehow met with community assistance. With

these things in mind, I believe that Grand Marais should focus on maintaining sustainable economic conditions for local businesses, and on providing essential service for retirees. Two essential services for retirees include 1. Adequate medical services, especially ambulance service, and for non-emergency transportation to medical services (such as Munising, Newberry, and Marquette), and 2. public transportation for basic needs such as shopping for food and other things. Many retirees are limited in their driving skills and need such assistance. We do not need things like additional, enhanced police presence (protection), with the possible exception of large, public events like the music festival in Summer. These large, public events should be responsible for providing such protection.

- Airport Road is dangerous
- I do not agree that snowmobiles have been on a "steady increase"; the snowmobile populations ebb and flows overtime and there are way less than there have been historically!
- I am seeing an uncomfortable and unnecessary shift in the culture of Grand Marais. I am watching while people buy property here without researching the traditional 4 season vibration of this small town and when they find a traditional cultural element, they don't like they set out to change it. They insist there is "more noise", "more recreational vehicles", "more tourism July 4th", and all of it they would find to be untrue had they done their research of all 4 seasons and historical ebb and flow. Things in Grand Marais are cyclical as they are everywhere. Stop trying to change us into where you came from!
- We don't want it to change from when we first visited 12 years ago, but after this summer, realize that this may not be realistic.
- Grand Marais should remain a beautiful quiet place to live and not a place that caters to short-term visitors who arrive in the large groups on ORV's or snowmobiles. Most visitors who come to stay a week or two or longer come for the natural beauty and quiet. To attract more to these visitors, we need good restaurants and interesting shops. The town center would be more attractive with better, better-looking, streetlights- not the tall utilitarian poles we now have.
- Develop and provide a means for summer residents to get rid of garbage similar to when you could purchase colored garbage bags. I'm sure some arrangement could be worked out with the current refuse disposal provider. Look into a possible "Dark Sky" designation area with a town event. Airport area would be a perfect venue.
- Snowmobiles must stay on trails. Quads and ORVs restricted by noise and less than 15 mph. More law to stop the speeds, noise of vehicle and party noise.
- I do appreciate the need for a plan. I just don't want my hometown swallowed up with Government control. Grand Marais reaped very little benefit from the National Park seizing property and control of a large swath of Burt Township land. CUPPAD's involvement in "The Plan" gives me pause.
- Re: #46 [lighting] - in some places there's a light at consecutive street intersections. At other places there's one light in 4 blocks. In residential areas.
- H-58 East speed limit needs to be reduced until past the Grand Marais Mercantile. 55 mph speed limit is too fast in the area! There are walkers, bikers, hikers, ORVs... someone is going to get hurt - or worse.
- Need to preserve our quaint, quiet village.
- Marina - I strongly believe that more docks are needed at the marina for full time and visitor docking. There are grants that can be applied for. Parking - more and more visitors will be coming to Grand Marais. More parking is necessary and don't use the marina for parking. Lines painted, Community Center lot paved with lines, move the basketball net to the tennis

court for parking space. Speed limit in town and coming into town. Rental properties - Don't restrict rentals outside of town. Every tourist town has them. Restrict the amount within the town limits to a certain percentage. Charge more than \$100 per year for rental properties.

- Too many wolves' sightings in town. They have been in our yard. Something needs to be done.
- Sidewalks need to be improved. Mine has been cracked, grass growing in it and place to stumble. I keep asking about getting it fixed.
- Must remember that tourism is the only viable industry left. Not only in Grand Marais but throughout most of the U.P. It must be allowed to flourish and grow but under control. Nothing is all good or all bad.
- Please paint lines on the streets every year, especially the walk / bike path on the Point and by the Post Office
- Short term renters do not support a community. They do not spend money in the community - they come supplied. The hotel people do spend money i.e.: restaurants, grocery, liquor. Short term renters feed the bears with their lack of concern for garbage.
- I feel it is important to get a sewer system first and a lot of other things will fall in place in Grand Marais.
- No wind farms on bay or Superior shore.
- My biggest issue is snowmobilers trespassing and throwing their garbage all over the woods. I know there is nothing you can do, and we just have to live with it. The rentals popping up all over on Nevins Lake. There is almost a dozen. Again, the tourists could care less about polluting, partying, noise and just being idiots. I came here for peace and quiet. I will be selling because of the overdevelopment.
- There are many people who don't pay taxes but are active in township affairs. Full time renters, residents in Superior Dunes (I know its Luce County) don't identify with Grand Marais and are very active in creating and promoting and supporting Grand Marais. Please see they get copies of this survey.
- The increased number of rental (short term) and non-owner-occupied properties leaves the population during the summer and fall with too many people that don't care or respect the community making it less desirable to be a resident. Has gotten much worse in the last 5 years or so.
- Burt Township is the perfect place to live, small town Mayberry feeling. It is situated beautifully on Lake Superior and has a nostalgic feeling (relaxed). No reason to hurry or worry about senseless things. You can feel proud and free living here especially with no police to add worrying about being ticketed for picking up your mail in your ATV. Living without police gives a strong feeling of a powerful helpful neighborly community. It is peaceful and relaxing, Heaven on Earth, very very beautiful!
- Many of the properties seem to have been sold as short-term rental properties with absentee owners. We need affordable housing for younger families and people who want to live and work here.
- We would like to see better snow removal in and around town, where the snow is blown into trucks and removed instead of plowing to the edges of the roads. This would eliminate the huge snow piles in town, the reduced visibility on corners and help residents and businesses in taking care of entrances, driveways, and parking access. This method is used in other parts of the U.P. that get snow like we do.

Not everyone passing through appreciates what Grand Marais or Burt has to offer and they are destructive and maybe criminal.
- 1 - Amendment to Zoning Ordinance regulating the size of residential dwellings. 2 - Strict limits on short term rentals. 3 - Specific, institutionalized methods to obtain input from non-resident property owners.
- I would like to see the campground get a bigger and better laundry facility. Campsites enlarged. I think it needs a huge facelift.
- Rental properties versus traditional motels. Seems unfair for motels to compete against people renting out their houses - "absentee landlords". Seasonal residents do not support the community in the cold winter months.
- Support the Historical Society and its programs! Encourage arts groups. Develop more cross-country ski trails. Develop a "Heritage Trail" (with interpretive signage) on the Coast Guard Point. Could utilize historic photos of old sawmills and docks. Hire a professional arborist to manage the Grand Marais trees instead of local amateur assessments of tree health. They have cut down too many beautiful trees! Instead of worrying so much about the ambulance, etc. why not try and get funding to build up staff and services for our local clinic! It already exists! Now staff it!
- Run electric to people in the Township. Should have bored it with the fiber that went in. Poor planning.
- I believe personal property rights should be respected. My opinion on what someone else does with their property is irrelevant
- I have watched the Township Board stray from taking care of Township properties and infrastructure to interfering with private property and lives. I would encourage them to revisit their original mandate and job description.
- I love Grand Marais and I think ideally, we can be mindful about maintaining the things that make it special now and making the community better for those who live here while sharing what's there with people from outside the community. I don't know the specifics, but it would be nice if the community could diversify the economy a bit to have something other than tourism to rely on.
- I don't dislike [ORVs]- but find it amazing they can drive hundreds of miles to get here but can't ride a few miles around town instead of through it.
- It's harder and harder to enjoy the night sky. Way too many too bright lights anymore.
- Just a thought: There's an event almost every weekend in summer - everything is driven / geared to tourists - more focus should be made on quiet weekends for full-time residents. We're treated as if we don't matter.
- The beaches are getting polluted by dog poop. There are many irresponsible dog owners just letting their dog's poop and not picking it up. The beach east was very bad this past year. Also,

dogs running loose. I love dogs and want to be able to walk beaches with them, but I use leash and pick up. I understand owners can have them off leash, but they (the owners) need to be responsible / considerate of others. The 4 wheel / side by sides are coming more problematic than snowmobiles. Some are way too loud. They're not out on trails - but going around / around and around town all day all night. Some driveway too fast and some are "little kids" driving. I wrote a separate suggestion for snowmobiles, but something similar could be done about them. Wintertime windows are closed but not in the Summer. Regarding snowmobiles, 4 wheelers, irresponsible people with dogs on beach - locals or local property owners, full-time local renters are a part of the issues / problems.

- Please address the concern that those who live and work in Grand Marais cannot afford adequate housing, meanwhile, retirees and snowbirds buy up second homes and rent them out as a passive income. There is an issue with the housing in Burt Township. There will simply never be a sense of community and the ability for constituents to raise their families here as it currently stands.
- The only caveat I would like to add would be in regards to the urgency I feel Burt Township's planning commission is under to enact some structural change to benefit all people's of Burt Township. To act as if half measures and small detail orientated changes will be enough to combat the inevitable change is unacceptable. Currently Grand Marais is no place to raise a family or to have some semblance of hope for upward mobility. The truth is it is a town whose exterior façade only masks the ugliness of poverty and the exploitation of both people and our Public Land in the sake of the tourist dollar. Tourism is not going away anytime soon, and rather than placate to what businesses and the privileged tell us we need to do or put up with in our community, I would like to see Burt Township make structural changes to empower the least fortunate within our township in the hopes of building something truly better.
- Grand Marais needs city sewer to grow and protect our ground water.
- I think a good analysis of the results would be full time residents vs. seasonal residents.
- I'm making an assumption that a consultant was engaged to construct this survey and adapted some standard master planning questions instead of developing questions specific to the uniqueness of Burt. Twp. The township is geographically vast and diverse. Most of the questions of this survey are focused on the "village" or "town" of Grand Marais. I travel to GM frequently, yet the property I own in Burt Twp. is closer to the far western edge of the township. For example, I understand the concern about the number of short-term rental properties. However, what may be legitimate concerns in a densely occupied R1 area, are likely non-issues in sparsely populated Recreation and LS/R districts. Twp. officials need to give this due consideration when developing proposed regulations. The wants, needs, desires, issues and concerns vary widely across the unique districts of the township.

- As a property owner on N. Lake Ave I received no notice or invitation for input prior to expansion of the paved parking at Agate beach. The amount of traffic-cars, motorcycles, atvs, campers, atv's, and motor homes on N Lake has increased to an outrageous level. The parking late at night and in to the early morning as well as the number of overnight campers is disturbing at best. The enlarged parking lot now blocks the water view from my house-instead i now look out at campers, RV's, and large trucks all day long. There is constant screaming ,yelling ,door slamming ,dogs barking, parking off the pavement, trash like used masks and diapers etc. on the ground. Very unhappy to the point i hesitate to come visit the property I have owned and enjoyed for over 25 years. In my opinion a very poorly executed idea. Additionally the lights outside the Fire/EMS building were replaced on the overhead door (south)side of the building but not on the west facing end of the building. Those older lights shine in my bedroom window forcing me to put up room darkening curtains-what a nuisance since I used to lay in bed able to look out the window at the night skies and stars. Hopefully those older lights are being replaced
- Ban side by sides. Grand Marais and Burt township needs to be preserved. The side by sides tear up roads and trails, the people in them litter and drive to fast. The noise pollution affects animal habitat and the rif raf that ride in them litter on the trails and have no respect for the trails or other people that are walking or hiking. Ban side by sides.
